Investment Summary

Granahan's Future Pathways Fund invests in 40-50 equities of small and mid cap ("SMID Cap") companies, focusing on traditional fundamentals while also uncovering the intrinsic value of societal impact. The goal of the strategy is intended to be flexible and adaptable to environmental and social issues as they arise, and able to rotate where the best opportunities exist for stock appreciation in this universe. The fund looks beyond ESG ratings data, instead focusing on the external benefit of the products and services provided by the holdings. 

Monthly Commentary

Conflicting opinions abound around the direction of inflation and interest rate with the election of Donald Trump. In November 2024, the Granahan Future Pathways UCITS Fund underperformed the Russell 2500 Growth with a total return of 1.3% (USD) compared to the benchmark's 11.9% (USD). This underperformance in the month was largely driven by a stock selection in Health Care, Information Technology and Industrials. With respect to sustainable objectives, Social Justice & Opportunity holdings significantly outperformed the benchmark, but it wasn't enough to offset the underperformance of the holdings in the Healthcare Outcomes & cost category. Core Growth companies were the strength in the portfolio with Special Situations lagging. President-elect Trump's policy proposals over the coming year, which include tariffs, deportations, tax cuts, and depreciating the value of the dollar, have the potential to be highly inflationary. The hope from this incoming administration is that any inflationary pressure will be more than offset by the disinflationary forces of deregulation (particularly energy), DOGE, and a peace dividend from ending all major global conflicts.

The Russell 2500TM Growth Index measures the performance of the small to mid-cap growth segment of the US equity universe. It includes those Russell 2500 companies with relatively higher price-to-book ratios, higher I/B/E/S forecast medium term (2 year) growth and higher sales per share historical growth (5 years). The Russell 2500 Growth Index is constructed to provide a comprehensive and unbiased barometer of the small to midcap growth market. The index is completely reconstituted annually to ensure larger stocks do not distort the performance and characteristics of the true small to mid-cap opportunity set and that the represented companies continue to reflect growth characteristics.

The composite, created in September 2020, is calculated by asset-weighting the performance of each account on a monthly basis. Accounts are included beginning with the first full month under management and terminated accounts are included in the composite. Performance calculations, expressed in U.S. dollars, produce a total return including cash and the reinvestment of dividends and interest. The dispersion is a standard deviation using equal-weighted total returns for accounts in the composite the entire year. The three-year annualized standard deviation measures the variability of the composite and the benchmark returns over the preceding 36-month period. Leverage is not utilized. Policies for valuing portfolios, calculating performance, and preparing compliant presentations are available upon request. Returns are gross of investment management fees, which when included, reduce investment returns. The standard management fee applicable is applied to calculate the net return. The standard fee for accounts managed in the Future Pathways style is payable quarterly in arrears and is calculated by applying the ANNUAL rate of 1.00% times the average value of the assets in the account on the last day of each month in the quarter. Fees are collected quarterly, which produces a compounding effect on the total rate of return net of management fees. Market value is based on trade date and security pricing is supplied by Telemet.
