### **Investment Summary**

Granahan's Future Pathways Fund invests in 40-50 equities of small and mid cap ("SMID Cap") companies, focusing on traditional fundamentals while also uncovering the intrinsic value of societal impact. The goal of the strategy is intended to be flexible and adaptable to environmental and social issues as they arise, and able to rotate where the best opportunities exist for stock appreciation in this universe. The fund looks beyond ESG ratings data, instead focusing on the external benefit of the products and services provided by the holdings. 



## **Monthly Commentary**

The Trump administration has taken over the White House with a sense of urgency and a raft of executive orders in numbers we have not seen historically. This has caused great volatility in the stock market. The Granahan Future Pathways UCITS Fund has lagged the Russell 2500 Index slightly with a return of 3.5% (USD) versus the Index' return of 3.8% (USD). Weakness came from the underweighted the Energy and Consumer Staples sectors. Overweight Health Care and Consumer Staples were also a penalty. Industrials are overweight and stock selection here contributed positively to performance as well as the underweight Information Technology and Financial sectors. Core Growth companies drove performance this month with Pioneers as the laggard. We are in the early stages of tremendous change in technology with AI pushing the envelope and impacting all industries. Many small companies are at the forefront of innovation and progress in this area.

The Russell 2500<sup>TM</sup> Growth Index measures the performance of the small to mid-cap growth segment of the US equity universe. It includes those Russell 2500 companies with relatively higher price-to-book ratios, higher I/B/E/S forecast medium term (2 year) growth and higher sales per share historical growth (5 years). The Russell 2500 Growth Index is constructed to provide a comprehensive and unbiased barometer of the small to midcap growth market. The index is completely reconstituted annually to ensure larger stocks do not distort the performance and characteristics of the true small to mid-cap opportunity set and that the represented companies continue to reflect growth characteristics.

The composite, created in September 2020, is calculated by asset-weighting the performance of each account on a monthly basis. Accounts are included beginning with the first full month under management and terminated accounts are included in the composite. Performance calculations, expressed in U.S. dollars, produce a total return including cash and the reinvestment of dividends and interest. The dispersion is a standard deviation using equal-weighted total returns for accounts in the composite the entire year. The three-year annualized standard deviation measures the variability of the composite and the benchmark returns over the preceding 36-month period. Leverage is not utilized. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request. Returns are gross of investment management fees, which when included, reduce investment returns. The standard management fee applicable is applied to calculate the net return. The standard fee for accounts managed in the Future Pathways style is payable quarterly in arrears and is calculated by applying the ANNUAL rate of 1.00% times the average value of the assets in the account on the last day of each month in the quarter. Fees are collected quarterly, which produces a compounding effect on the total rate of return net of management fees. Market value is based on trade date and security pricing is supplied by Telemet.
